- 2. All bikers must have helmets to participate in the program. Failure to wear a helmet will result in dismissal from the program.
- 3. Bikes must be parked in the bike rack or designated bike parking area once at school.
- 4. Parents must check their children's bikes for safety before starting the program and then ensure proper working order throughout the school year.
- 5. Parents will assume full responsibility and liability for their student's conduct and safety. The school district cannot legally assume any responsibility or liability in connection with a child's bicycle if it becomes lost, stolen or damaged. In addition, parents/guardians release the Dearborn Public Schools, it's employees, trustees and officers from any and all liability resulting from any injuries, which may occur to my child as a result of his/her riding a bicycle or walking to school.
